### **1. Who can participate ?**

Any brands who work with artisans and use natural fabrics.

### **2. I use polyester fabrics but work with artisans ?**

We can accept small percentage of them as long as your collections does not end up in landfill.

### **3. We use mass production factories but work with organic and natural fabrics .**

We can accept them with appropriate certification either GOTS/ SEDEX .

### **4. We use re-cycle polyester from PET bottles.**

We would require you to prove the system of operations showing that your end consumer goods does not goes to land-fill and you have a system in place to re-process them with Certifications.

### **5. My collections are hand made in small quantities**

We can accept them and help you in growing your markets.

### **6. We work from waste polyester fabrics and create work of art ?**

We accept brands who use made-up fabrics in to fashion and making sure they do not end up in land-fill.

### **7. I use hemp/ poly blends ?**

We can accept if your collection is made from recycle blends and again proving that they do not go to land-fill

### **8. I work on second-hand / vintage collection?**

Yes, we accept vintage fashion sell/ rental operations

## **Terms and Conditions**

1. Once signed-up, the payment must be paid in full.
2. The payment is non-refundable, unless there is cancellation of the event due to unforeseen situation.
3. Brands/ designers must send their goods to and from at their own cost. We are not responsible for any duties and taxes that could incur with the goods and all the responsibilities fall on the brands/ designers.
4. The Company is responsible only to collect the goods and upon collection and re-sending the brands/ designers will be notified.

6. Full refund is made only when the show gets cancelled.
7. The Company has the right to change the dates of the program based on the unforeseen circumstances but this does not imply the show will be cancelled and there will be no refund.
8. Company will send the footages of the show filmed after the event and date of the film release will be notified after the event.
9. Any third party promotions will be updated to the brands after the show.
10. All the goods must be packed and necessary dis-infecting measures to the products must be made by the brands. Once the goods are received, the company makes sure they are dis-infected due to COVID measures.
11. The company will comply with COVID protocols and hence we request brands to support and make sure the goods are properly packed with appropriate details provided in the packing list.
12. The company takes the responsibility to re-pack the goods in the given condition and make the necessary arrangements for the brands to collect the goods.
13. If the customs charges are made to the Company, then brands/ designers are responsible to settle the appropriate customs and duty charges ASAP against the bill.
